# **INTRODUCTION**

Your privacy is important to us, so through this document we explain what data we collect from users, how we use it and for what, among other indications. Those over 14 years of age may register as users without the prior consent of their parents, tutors or legal representatives. In the case of minors under 14 years of age or identified as "legally incapable", we will always need the consent of the parent, or of the tutor, or legal representative.

For your information, we will never ask for more information than we actually need for the required services; We will never share it with third parties, except by legal obligation or with your prior authorization; and we will never use your data for another purpose not previously indicated.

As a user, you should carefully read this privacy policy on a regular basis, and whenever you enter your personal data, since this document may be modified because the provider can modify any type of information that may appear on the web to comply with the regulations or update the policy, and without there being an obligation to pre-notify or inform users of these obligations, the publication on the provider's website being sufficient.

<u>www.minishower.pro</u> hereinafter the Provider, as responsible for the website, in accordance with the provisions of Regulation (EU) 2016/679 of April 27, 2016 (RGPD), Spanish Organic Law 3/2018 of December 5 (LOPDGDD) and other regulations current legislation on the protection of personal data, and by Spanish Law 34/2002, of July 11, on Services of the Information Society and Electronic Commerce (LSSICE), informs you that we have implemented the necessary security measures, of a technical and organizational nature, to guarantee and protect the confidentiality, integrity and availability of the data entered.

# **PURPOSE OF THE TREATMENT**

Your personal data will only be used for the following purposes:

- Carry out the necessary commercial and administrative procedures with the users of the web;

- No profiling and usability analysis will be carried out.

- The data of clients and / or suppliers will be treated, within the contractual relationship that binds them with the Responsible, in compliance with the administrative, fiscal, accounting and working obligations that are necessary under current legislation.

In accordance with the Spanish LSSICE law, <u>www.minishower.pro</u> does not perform SPAM practices, therefore, it does not send commercial emails that have not been previously requested or authorized by the User. Consequently, in all the communications that you will receive from the Provider, the user has the possibility of canceling their express consent to receive our communications.

We will not process your personal data for any other purpose than those described except by legal obligation or judicial requirement.

# **LEGITIMATION OF THE TREATMENT**

The legal basis for the treatment of the data is your consent granted to carry out the purposes described above, which will be requested at the time of marking the corresponding box when collecting your data, or through your express consent granted in another document.

Failure to provide the requested personal data or failure to accept this data protection policy implies the impossibility of subscribing, registering or receiving information on the Provider's products and services.

In cases where there is a prior contractual relationship between the parties, the legitimacy for the development of administrative, tax, accounting and labor obligations that are necessary under current legislation will be the prior existence of the commercial relationship established between the parties.

# **RECIPIENTS OF ASSIGNMENTS OR TRANSFERS**

www.miniducha.com does not carry out any transfer or communication of data unless there is a reasonable need to comply with a judicial procedure, legal obligation or after obtaining the user's consent.

Nor will international transfers of your personal data be made without your prior consent without prejudice to being able to block or cancel your account if there may be indications of the commission of a crime by the user. The information provided will only be that available to the Provider at this time.

The treatment of the data of said entity is regulated by means of a contract of the person in charge of the treatment between the Provider and said company. In no case will this person in charge of the treatment subcontract services that involve any data processing by third parties without our prior consent.

#### **RIGHTS OF INTERESTED PERSONS**

As a user or interested party, you can request the exercise of the following rights before <u>www.minishower.pro</u> by submitting a letter to the postal address of the heading or by sending an email to: <u>hello@minishower.pro</u> indicating as Subject: "DATA PROTECTION, EXERCISE RIGHTS", and attaching a photocopy of your ID or any similar means in law, as indicated by law.

Rights:

• Right of access: allows the interested party to know and obtain information about their personal data subjected to treatment.

• Right to rectification or deletion: allows you to correct errors and modify the data that prove to be inaccurate or incomplete.

• Right of cancellation: allows data that turns out to be inappropriate or excessive to be deleted.

• Right of opposition: right of the interested party not to carry out the processing of their personal data or to stop it.

• Limitation of the treatment: it entails the marking of the personal data conserved, in order to limit its future treatment.

• Portability of the data: facilitation of the data object of treatment to the interested party, so that he can transmit them to another person in charge, without impediments.

• Right not to be subject to automated individual decisions (including profiling): right not to be subject to a decision based on automated processing that produces effects or significantly affects.

#### **CONSERVATION OF YOUR DATA**

However, we will keep certain personal identification and traffic data for a maximum period of 2 years in the event that it is required by the Judges and Courts or to initiate internal actions derived from the improper use of the website.

It will not be the subject of decisions based on automated treatments that produce effects on your data.

Security measures. The data you provide us will be treated confidentially. The data collected by the responsible in charge are the following:

- Those that users provide through the different services offered on the website
- Those included in the different forms provided on the website

- Data collected through "cookies" to improve the browsing experience as reported in the cookie policy.

The refusal to supply the mandatory data will make it impossible to meet the specific request in question. You declare that the information and data you provide us are accurate, current and truthful. We ask that in case of modification, immediately communicate it so that the information being processed is updated at all times and does not contain errors.
